29 30 Exemptions to the live-on requirement may be considered for the following reasons:

- Married students or students with dependents who live in the home with the student.
- Age 21+ prior to the start of classes for the year in which they are enrolling. Students who turn 21 in the fall semester may appeal to live off campus for the spring semester.
- Under the age of 21, living with immediate family member, within 50 miles of the DSU-Dickinson campus.
